Candidates should produce all certificates in ORIGINAL viz (1)TGEAPCET-2024 Rank card & Hall ticket (2)Memorandum of Marks of Intermediate or its equivalent (3)Memorandum of Marks of SSC or its equivalent (4)Study Certificates from 7th Class to Intermediate (5)Residence certificate for preceding seven years of the qualifying examination i.e. Intermediate in respect of candidates who had private study without any institutionalized education (6)Residence Certificate of Father or Mother for a period of 10 years in Telangana / A.P. excluding the period of their employment outside A.P. from M.R.O. in case of Non local candidates. (7) **Minority Candidates whose parental income is less than Rupees One Lakh Fifty Thousand and Two Lakhs per annum (for Rural and Urban Areas respectively) are exempted from the payment of Tuition Fee provided they furnish the Income Certificate issued by the MRO on or after 01-04-2024.**

Fee Particulars: Tuition fee fixed by Government, of Telangana on the recommendations of TAFRC from the block period 2022-23 to 2024-25. In addition, candidates will have to pay non refundable amount of Rs.1000/- and Rs.1500/- towards registration and counseling fee respectively. Fee shall be remitted by way of Demand Draft Drawn in favour of

Payable at Hyderabad or in cash at the bank counter located at the admission Centre. Fee shall be paid in full at the time of counselling and no part payment will be accepted for those students who are not eligible for Tuition Fee Reimbursement from the Govt.

Candidates are informed that they should satisfy the admission rules prescribed by the respective universities and should be prepared to pay the Tuition Fee as applicable. The above fee structure is subjected to any enhancement by the Govt. More number of candidates called for counselling than the seats available. Hence mere attending the counseling does not guarantee a seat.

Note:

1. This notification is itself a call for counselling. No separate call letters shall be sent to individual candidates. Candidates may have to stay a day extra, if required.
2. Minority Students who take admission in a college through SW-I can slide to a college in SW-II-AC and vice versa, paying an amount of Rs.1000/- and Rs.1500/- towards Registration & Counselling fee respectively.
3. Last date for cancellation of admission taken through SW-II is 04.08.2024.
4. Last date for the allotted candidates of convener, TGEAPCET-SW-II to report to their respective college is 03.08.2024.

5. It is mandatory for students to produce Aadhaar Card to avail the Tuition Fee Reimbursement from the Government.
